- 1. Wister Public School plans continue with implementation of prevention strategies to create a safe learning environment while staying in person as much as possible. Wister Public School was fortunate enough to be able to stay in person the majority of the 20-21 school year, but hopes to improve upon strategies used for an even better 23-24 school year. We developed an ESSER Team of stakeholders to give guidance on best use of funding. The team developed many plans including the following: School busses for increase social distancing opportunities, school mini-vans for food delivery purposes, foggers for disinfectant purposes, update air-conditioning across campus for safer air quality, remodeling bathrooms for hands free, replacement of doors/windows for safety and replace carpet with tile for disinfecting purposes.

Wister Public School team of stakeholders determined the use of the 20% of funds would be best utilized to offer an after school intervention with tutors and

intervention programs for students needing the extra assistance. This afterschool program should help bridge the gap of learning loss from the past year. Summer School is already offered at the district through the Choctaw Summer Program, 21st Century Grant, and has very good attendance. In addition to these, Wister Public Schools will offer Summer Enrichment Camps, which will help bridge the gaps in all aspects of education. These camps range from athletic subjects to all educational subjects. Students participating will receive additional support, such as books and equipment, as well as online based academic intervention programs to offer added opportunities for growth.
